# Town of Tecumseh and Windsor-Essex County Health Unit Come Up Short: No Science Indicating that Fluoride is Safe During Pregnancy With Respect to IQs and ADHD Symptoms in Offspring

Bold claims from Tecumseh Mayor McNamara and Medical Officer of Health Dr. Wajid Ahmed of the Windsor-Essex County Health Unit were recently published in the Windsor Star regarding the safety of community water fluoridation.

Thus, information requests for peer-reviewed scientific research showing that fluoride exposure during pregnancy is actually safe with respect to IQ and ADHD symptoms in offspring were sent to both the Town of Tecumseh and the Windsor Essex County Health Unit.

Recent high quality, U.S. government-funded research, that had previously been provided to both Tecumseh Council and the Medical Officer, indicates the exact opposite. This credible research published by an international team of top public health departments found that fluoride exposure during pregnancy is associated with <a href="lower IQs">lower IQs</a> and increased <a href="ADHD symptoms">ADHD symptoms</a>. And the maternal fluoride exposures in this research were very similar to those recently <a href="reported">reported</a> for Canadian fluoridated cities.

The Town of Tecumseh dealt directly only with the part of the information request relating to Mayor McNamara, and provided <u>no responsive records</u>. (The privacy officer provided materials but none contained or cited any research papers showing that fluoride exposure during pregnancy is safe with respect to IQ and ADHD symptoms.) The town dealt with the part of the request relating to Dr. Ahmed by transferring the request to the Windsor Essex County Health Unit.

The Health Unit addressed the part of the request relating to Mayor McNamara by transferring the request to the Town of Tecumseh. It dealt directly only with the part of the request relating to Dr. Ahmed, seeming to contradict his claims, and stating "there are no responsive records".

Dr. Wajid Ahmed, medical officer of health for the Windsor-Essex County Health Unit:

"As a persons of science, we stay up to date on all research and areas we work with," Ahmed said. "We look at the results and based our recommendations on that. One research paper does not negate longstanding research that dates back 73 years that shows fluoride is safe."

Tecumseh Mayor Gary McNamara:

"A lot of it was repetitive, but I must say I'm proud how council did their homework on this and based their decision on good science.... The reality is the science is solid and peer-reviewed."

### **Description of Requested Items:**

All of the primary peer-reviewed scientific research papers on fluoride exposure <u>from community water fluoridation during pregnancy</u> published in the last 73 years, referred to by Dr. Ahmed and Mayor McNamara in their above statements published in the Windsor Star, showing that the fluoride exposure from community water fluoridation during pregnancy is safe with respect to IQ and ADHD symptoms in offspring.
- 2. All other primary peer-reviewed scientific research papers on fluoride exposure <u>during pregnancy</u> published in the last 73 years, referred to by Dr. Ahmed and Mayor McNamara in their above statements published in the Windsor Star, showing that the fluoride exposure during pregnancy is safe with respect to IQ and ADHD symptoms in offspring.
- 3. All non-primary peer-reviewed scientific research papers on fluoride exposure during pregnancy published in the last 73 years, referred to by Dr. Ahmed and Mayor McNamara in their above statements published in the Windsor Star, showing that the fluoride exposure during pregnancy is safe with respect to IQ and ADHD symptoms in offspring.
