Dear Premier Kenney, Minister Shandro, Dr. Hinshaw and Ms. Jolin,

This is a formal request for access to general records, made under Alberta's *Freedom of Information and Protection of Privacy (FOIP) Act*, as a result of public statements made by Dr. Hinshaw:

**"...I, Dr. Deena Hinshaw, Chief Medical Officer of Health have initiated an investigation into the existence of COVID-19 within the Province of Alberta... *the investigation has confirmed that COVID-19 is present in Alberta*"**

in [CMOH Order 37-2021](#), July 13, 2021, and

**"...the investigation has confirmed that COVID-19 is present in Alberta and constitutes a public health emergency as a novel or highly infectious agent that poses a significant risk to public health"**

in [CMOH order 06-2021](#), March 11, 2021; [CMOH Order 09-2021](#), April 8, 2021; [CMOH order 34-2021](#), June 30, 2021; [CMOH order 10-2021](#), April 10, 2021.

**Kindly advise ASAP how I may go about submitting payment of any required application fee(s).**

**Description of Requested Records:**

All studies and/or reports in the possession, custody or control of Premiere Kenney, Minister Shandro, Dr. Hinshaw or

any of their respective offices/institutions describing the **purification** (i.e. via filtration and ultra-centrifugation) of any "COVID-19 virus" (aka "SARS-COV-2", including any alleged "variants" i.e. "B.1.1.7", "B.1.351", "P.1") directly from a sample taken from a diseased human, where the patient sample was not first combined with any other source of genetic material (i.e. monkey kidney cells aka Vero cells; fetal bovine serum).

Please note that I am **not** requesting studies/reports where researchers **failed to purify** the suspected "virus" and instead:

- cultured an unpurified sample or other unpurified substance, and/or
- performed an amplification test (i.e. a PCR test) on the total RNA from a patient sample or from a cell culture, or on genetic material from any unpurified substance, and/or
- fabricated a genome based on millions of sequences detected in the total RNA from a patient sample or from a cell culture or from any unpurified substance, and/or
- produced electron microscopy images of unpurified things in a cell culture.

#### Clarification of Request

For further clarity, please note I am already aware that according to virus theory a "virus" requires host cells in order to replicate, and I am not requesting records describing the replication of a "virus" without host cells.

Further, I am **not** requesting private patient information, or records that describe a suspected "virus" floating in a vacuum; I am simply requesting records that describe its **purification** (i.e. **separation** from everything else in the patient sample, as per standard laboratory practices for the purification of other very small things).

Please note that my request includes any study/report matching the above description, for example (but not limited to) any published peer-reviewed study **authored by anyone, anywhere**.

If any records match the above description of requested records and are currently available in the public domain, please provide enough information about each record so that I may identify and access each one with certainty (i.e. title, author(s), date, journal, where the public may access it). Please provide URLs where possible.

Hello,

With whom am I communicating?

Am I required by the legislation to submit a request to the Dept. of Health through this portal, and am I prohibited by the legislation from using more than 1500 characters for my description of requested records and from using "special characters" and from copying and pasting my description of requested records into the portal?

The reason I ask is that I have attempted twice now to submit my request through this portal, and was forced to shorten the description of requested records. I refreshed the page, started all over again with a description that is only 1481 characters (including spaces) and I'm still getting this message:

*The maximum character limit is 1,500 and you cannot enter any special characters. Do not copy and paste request text in this space.*

I do not have time to retype my description into the portal, which seems a bizarre and ridiculous requirement that serves no purpose other than to make things difficult for the requester.

Below is my shortened description that is being rejected by the portal.

*All studies and/or reports in possession, custody or control of the Dept describing purification of any "COVID-19 virus" (aka "SARS-COV-2", including any alleged "variants" i.e. "B.1.1.7", "B.1.351", "P.1") directly from a sample taken from a diseased human, where the sample was not 1st combined with any other source of genetic material.*

*I am not requesting studies/reports where researchers failed to purify the suspected "virus" and instead:*

- *cultured an unpurified sample, and/or*
- *performed an amplification test on genetic material from an unpurified substance, and/or*
- *fabricated a genome based on sequences detected in an unpurified substance, and/or*
- *produced electron microscopy images of unpurified things.*

*I am not requesting records describing the replication of a "virus" without host cells, or private patient info or records that describe a suspected "virus" floating in a vacuum; simply records that describe its purification (i.e. separation from everything else in the patient sample, as per standard laboratory practices for the purification of other very small things).*

*My request includes any study/report matching the above description, i.e: any published peer-reviewed study authored by anyone, anywhere.*

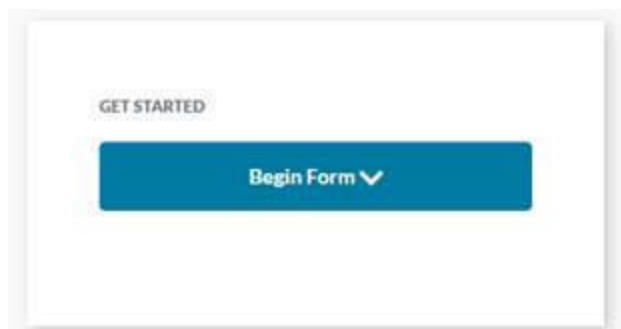

Hello,

With whom am I communicating? Please provide your name, as I require it for my records.

My request is for: "*All studies and/or reports in the possession, custody or control of Minister Shandro, Dr. Hinshaw or Alberta Health*". It has nothing to do with Alberta Health Services.

According to the Ministry's website, it is the **Ministry** that sets policy and direction, not AHS.

And, as stated in my request, it is **Dr. Hinshaw's** name that appears in CMOH orders, claiming to have "*initiated an investigation into the existence of COVID-19 within the Province of Alberta*" and that "*the investigation has confirmed that COVID-19 is present in Alberta*".

Section 10 of the Act states:

**"Duty to assist applicants 10(1)**

*The head of a public body must make every reasonable effort to assist applicants and to respond to each applicant openly, accurately and completely."*

Section 12 of the Act states:

**"Contents of response 12(1)**

*In a response under section 11, the applicant must be told*

- (a) whether access to the record or part of it is granted or refused,*
- (b) if access to the record or part of it is granted, where, when and how access will be given, and*
- (c) if access to the record or to part of it is refused,*
  - (i) the reasons for the refusal and the provision of this Act on which the refusal is based..."*

I have already waited patiently for **3 months**, and I now require an open, accurate and complete response from Alberta Health that **clearly states** whether or not Alberta Health has any records that match my description, and if so, whether or not access will be provided.

Be advised that all of the communications related to my August 13, 2021 request will be made public within the next few days.

Hello Jilliane,

My original request on August 13 was sent to [health.infoaccess@gov.ab.ca](mailto:health.infoaccess@gov.ab.ca) over 3 months ago and was for "*All studies and/or reports in the possession, custody or control of Premiere Kenney, Minister Shandro, Dr. Hinshaw or any of their respective offices/institutions*" (see attached).
