I communicate in everyday English, not legalese or commercial jargon.

I wrote to you about this matter via registered mail on December 19, 2022 (RN 645 133 374 CA) and through your website on September 24, 2023 (see the enclosed email and screenshot) but did not receive a response from you.

On November 28, 2022, a man acting under your control forced incoherent internal corporate forms that are not addressed to me onto me, by mixing them with my belongings. (See Aclosed Capies)

I have never been served with a summons or any proceedings issued by a court in relation to this matter.

I have not been served with a verified claim of trespass or an "offence notice" in relation to this matter.

I have never given an undertaking to a peace officer or "entered into a recognizance" for my appearance in court.

Therefore I could not have "failed to appear" in court in relation to this matter.

Nevertheless, this matter was before a "court" apparently using the name Ontario Court of Justice, Milton, on December 19, 2022. The man Mark J. Curtis acted as Justice of the Peace.

On the record in courtroom M9, Mark did, I believe unlawfully, threaten men and women that when "their name" was called they must attorn themselves to the court by stating the name and nothing else, or else he would issue a warrant for their "arrest" and they might spend Christmas in jail.

I had no obligation to "appear" or attorn myself. The name "CHRISTINE MASSEY" was called and I did not speak. Mark did issue a warrant.

On October 26, 2023 this matter was still listed as "Case Number 1211998221210303201" on the justiceservices.jus.gov.on.ca website, with a bench warrant indicated.

I have no desire to open a "My Ontario Account" and cannot lawfully be forced to associate in such a manner. Therefore I am no longer able to access the registry of court cases at justiceservices.jus.gov.on.ca, which appears to be a private registry.

Therefore I ask you:

Has this matter been permanently removed from the registry yet, and has the warrant been quashed yet?

If not, I ask that you kindly ensure that this warrant is quashed/cancelled, and that this entire matter is permanently withdrawn/concluded immediately, and that nothing will show up in any background checks or the registry or anything else that could further damage my reputation and cause me more stress.

For the last 16 months I have been afraid to visit a courthouse or police station or anywhere else that someone acting as peace or policy/police officer might be.

I ask that you kindly respond to me in writing about this.

I also ask again that you return the property to me. Please have your agents send it by registered mail to the address provided below.

I communicate in everyday English, not legalese or commercial jargon.

I wrote to you about this matter via registered mail in letters dated December 1, 2022 (RN 645 132 087 CA) and December 19, 2022 (RN 645 133 391 CA), through your website on September 24, 2023, again via registered mail on March 25, 2024 (RN 743 302 183 CA) and again on April 25 (RN 743 302 152 CA) but did not receive a response from you.

One of your agents concealing their identity and signing as "Property & Evidence Management Unit" sent a letter dated April 10, 2024, labeled "HALTON REGIONAL POLICE SERVICE", to the address I provided you, threatening to "dispose of" property that your agents took from me on November 28, 2022 if "Christine Massey" does not claim the property by tomorrow, May 10, 2024.

Further, your agent states "You **MUST** call to make an appointment... If you cannot attend... you may designate someone to come on your behalf... **Please bring identification with you**..."

For the last 17 months I have been afraid to visit a courthouse or police station or anywhere else that someone acting as peace or policy/police officer might be.

I cannot in good conscience ask anyone else to get involved in this matter given the behavior of your agents.

Destruction of the property would constitute further trespass and my fee for destruction of said property without my express written consent is \$1,000,000 CAD payable immediately in cash.

Kindly have your agent(s) return said property by registered mail to the address provided in my last letter.
