Dear Christine

Thank you for your continued interest in developing your understanding of science and in particular molecular biology of viruses. I have spent many happy years in research laboratories carrying out PCR reactions, sequencing genes, growing cells in tissue culture and performing genetic studies.

Although I don't normally recommend Wikipedia as a resource due to its open editing, there is a reasonably accessible introductions to viruses here

https://en.wikipedia.org/wiki/History_of_virology which details many of the early experiments and has extensive references linked to the primary scientific studies carried out that have identified viruses of many types.

As I have explained many times on social media, it is very difficult to isolate viruses as they are obligate intracellular pathogens, and culturing and isolating them requires specialist equipment. However, no health authority needs to isolate whole viral particle to detect it's presence. It is enough to identify a unique sequence of the nucleic acid to identify the presence of the virus. These tests, whether PCR or LFT, are rapid and relatively easy to carry out and therefore suitable for a diagnostic setting such as a hospital.

One again if you have evidence that I have committed fraud, it is your public duty to report that evidence to the relevant authorities.
